## **Decontamination Certificate**

## For service or repair of IVD Medical Device and Laboratory equipment

We at Mast Group Ltd. require all customers to complete a Decontamination Certificate when returning medical and laboratory equipment for repair or service, to ensure that our staff are not exposed to any health risks arising from hazardous or infectious materials.

- 1. Under the Health and Safety at Work Act (c.37 Pt. 1.3-(1). "It shall be the duty of every employer to conduct his undertaking in such a way as to ensure, so far as is reasonably predictable, that persons not in his employment who may be affected thereby are not exposed to risks to their health or safety."
- 2. A Decontamination Certificate is required for all equipment (one per item) which is returned to Mast® for service, maintenance or repair on site, or which is returned to our premises after a period of loan or demonstration. The decontamination certificate must be fully completed, signed by the customer and returned with the item.
- 3. Mast Group Ltd. reserve the right to delay the commencement of any work until such a Decontamination Certificate has been completed by the customer as evidence that the equipment has been suitably decontaminated and made free from any significant health or safety risks.
- 4. Where equipment is being returned to our premises we ask you to first contact the Customer Services Manager as detailed in point 5 below. You will be issued with a "Returns Authorisation Number" which will be your reference for future correspondence. You will be required to include the signed Decontamination Certificate within the packaging in an easily accessible place. A Returns Authorised label must be attached to the outside of the packing where it can be clearly seen.
