- 8-well strip tubes containing lyophilised single-reaction amplification pellets with primers against specific CRE targets in a set orientation (ART P1-8)
- 2. Lyophilised Inhibition Control DNA (CRE ICDNA)
- 3. Reconstitution Buffer 3 (RB3)
- 4. Molecular grade water (WTR)

#### Hazardous ingredients:

Lyophilised 8-well strip-tubes (ART P1-8) — A lyophilised mixture containing enzyme, DNA-binding dye, dNTPs, salts and buffering agents
at specific concentrations that, when reconstituted, give the base environment for Loop-mediated isothermal amplification. These pellets also
contain specific oligonucleotides at set concentrations that, when reconstituted, can amplify set CRE targets and CRE ICDNA controls under
isothermal conditions.
